Consideration of Operating Budget for the SmartState Program, Fiscal Year 2011-2012

Background

Attached please find the proposed fiscal year 2011-2012 operating budget approved by the SmartState Review Board at its June 6, 2011, quarterly meeting. As required by statute, the operating budget must be submitted to the Commission for approval. The SmartState Review Board is charged with overseeing the SmartState Program and with annually providing the Commission on Higher Education "a schedule by which applications for funding are received and awarded on a competitive basis" (S.C. 2-75-10). The Commission must also approve the program's annual operating budget: "all necessary funds for the prudent operation of the board..." (S.C. 2-75-70).

The SmartState Review Board issued no awards during fiscal year 2010-2011. An RFP was issued for SmartState Commerce Awards in the amount of \$6 million, but the Review Board deferred awards until fiscal year 2011-2012. To date, the SmartState Review Board has awarded \$197.6 million for the creation of 49 Centers of Economic Excellence and 87 specialized endowed professorships.

The proposed 2011-2012 SmartState operating budget is \$3,978 less than the 2010-2011 approved budget level of \$853,262. Some individual budget lines were reorganized to accommodate the new state accounting system (SCEIS). Overall individual budget line decreases include \$10,000 for Council of Chair activities, \$3,619 for Telephone (which was assimilated into the "Other Contractual Services Line"), \$3,539 for Liability Insurance, and \$2,000 for Equipment (which was assimilated into the "Supplies/Equipment" line). The only overall individual budget line increase is \$10,000 for "Staff Travel and Conferences" (for regional and national promotion of the program).

Recommendation

The Committee on Academic Affairs and Licensing commends favorably to the Commission the annual operating budget as approved by the SmartState Review Board for FY 2011-12.
