**MEMORANDUM**

Subject: Home School Students and LIFE Scholarship Eligibility

**Purpose:**

Home School Students and LIFE Scholarship Eligibility: The Commission staff is providing institutions with the requirements herein for determining LIFE Scholarship eligibility for home school students for the 2007-08 academic year and thereafter.

**Home school parents or legal guardians are allowed to approve students' transcripts and to convert students' transcripts to the UGS to meet the GPA requirement for the LIFE Scholarship.** The home school transcript must include a statement or a notation indicating that the GPA listed on the home school student's transcript is based on the SC Uniform Grading Scale (UGS). In addition, if the GPA listed on the home school student's transcript is not based on the SC Uniform Grading Scale, then the student must have the grades converted to the UGS and resubmit the converted transcript to the institution to be awarded the LIFE Scholarship. Transcripts that are hand-written and/or transcripts that are not converted to the SC Uniform Grading Scale will not be accepted for LIFE Scholarship eligibility.

**LIFE Scholarship Eligibility for First-time Entering Freshman:**

**1. Eligibility Criteria:**

All students must meet the following initial eligibility criteria for the LIFE Scholarship:

**Initial Eligibility Requirements for First-time Full-time Entering Freshmen Attending Four-year Institutions (meet two of the three criteria):**

- Minimum 3.0 cumulative GPA based on the SC Uniform Grading Scale;
- Minimum 1100 SAT or 24 ACT; or

- Rank in the top 30% of the graduating class based on the SC Uniform Grading Scale.

### **Initial Eligibility Requirements for First-time Full-time Entering Freshmen**

#### **Attending Two-year Institutions:**

- Minimum 3.0 cumulative GPA based on the SC Uniform Grading Scale (the standardized test score and class rank requirements are waived).

#### **Home School Associations:**

A home school student who has successfully completed a high school home school program in this State in the manner required by law may qualify for a LIFE Scholarship, if the student has met the eligibility criteria. In order for a home school student to qualify for a State scholarship, the home school program must be sanctioned according to one of the following:

1. The board of trustees of the district in which the student resides under Section 59-65-40;
2. The South Carolina Association of Independent Home Schools (SCAIHS) under Section 59-65-45; or
3. A home school association approved under Section 59-65-47 (Third Option Home School Associations).

#### **Home School Students and LIFE Scholarship Eligibility:**

To be eligible to receive the LIFE Scholarship, all students must have their grades converted to the SC Uniform Grading Scale (UGS) upon high school graduation. Students who are home schooled **must** have grades converted to the Uniform Grading Scale to be awarded the LIFE Scholarship. Beginning with the 2007-08 academic year, institutions must determine LIFE Scholarship eligibility for students who graduate from home school programs as identified above by using the GPA based on the SC Uniform Grading Scale listed on the student's transcript. The home school transcript must include a statement or a notation indicating that the GPA listed on the home school student's transcript is based on the SC Uniform Grading Scale. If the GPA listed on the home school student's transcript is not based on the SC Uniform Grading Scale, then the student must have the grades converted to the SC Uniform Grading Scale and resubmit the converted transcript to the institution to be awarded the LIFE Scholarship.

Home school students must submit an official home school transcript indicating that the student's cumulative grade point average is based on the SC Uniform Grading Scale. If the home school student is unable to have his or her grades converted to the SC Uniform Grading Scale, then the student **cannot** be awarded the LIFE Scholarship and **must** earn eligibility for the Scholarship by maintaining a minimum 3.0 LIFE GPA and 30 credit hours by the end of each academic year at an eligible institution to be awarded the LIFE Scholarship for the remaining terms of eligibility. Transcripts that are hand-written and/or transcripts that are not converted to the SC Uniform Grading Scale will not

be accepted for LIFE Scholarship eligibility. Institutions and students must comply with all requirements as established in state statute and regulation for the LIFE Scholarship.
