Chairman's Report:

Chair Hofferth recognized Commissioner Bettie Rose Horne to deliver remarks, which will be published in the minutes, in tribute to Dr. Joann R.G. Boyd-Scotland, President Emeritus of Denmark Technical College, who passed away on February 10, 2016.

Chair Hofferth discussed activities related to meetings of the House Education and Public Works [ad hoc committee on Higher Education Governance](#) that has been meeting and recently advanced for consideration of the Committee's Higher Education Subcommittee recommendations for legislation ([H.4833](#)) relating to clarification of CHE's authority. He commented on CHE's work to vet, analyze and clarify its statutes over the past six months, noting funding limitations on the agency in carrying out its core mission and that CHE's FY 2016-17 budget request is intended to address the need for adequate tools and resources necessary in order to make decisions as the coordinating body for South Carolina higher education which will best benefit institutions, both individually and collectively, and most importantly, our students.
