Mr. Tim M. Hofferth, Chapin, Governor's Appointment at Large, Chair. Appointed by the Governor on 9/15/2015 and confirmed by the Senate on April 6, 2016.

Mr. Hofferth began serving on the Commission in March 2015 as an at-large appointee of the Governor. He is currently the Chairman and CEO of TMH Consulting, LLC and has been involved with higher education for the last 25 years in a variety of capacities. He served as a University Administrator and as the President and COO of one of the nation's largest multi-media rights companies. As President and COO of Nelligan Sports Marketing, Inc., he represented over 40 colleges and universities nationwide. He fueled the creation of this multimillion-dollar startup business for over 14 years which resulted in a strategic acquisition in February 2014, creating the largest collegiate multimedia rights holder in the country with 97 institutions. At 34 years old, he was one of the youngest Division I Director of Athletics in the country at Villanova University. Mr. Hofferth was on the Villanova University Vice President's Council and on the Executive Committee of the Big East Conference. In 2001, he was recognized by Street & Smith's Sports Business Journal as a "40 Under 40" recipient, identifying him as one of the most influential leaders in the sports business industry. Currently residing in Chapin, S.C., he earned his Bachelor of Arts from the University of South Carolina, Aiken and his Masters of Education from the University of South Carolina, Columbia.

Dr. Settlemyer has Bachelor and Master of Science degrees in Speech Communication Consultancy and Occupational and Adult Education from Oklahoma State University. Admiral Charles Munns, Aiken, Governor's Appointment 2nd Congressional District Representative. Appointed to CHE in 2011. Committee Assignments: Governmental and Administrative Affairs (Vice Chair); Academic Affairs and Licensing

Currently the President of Munns Advisement, LLC, Admiral Munns was formerly the President and Chief Executive Officer of the Savannah River Nuclear Solutions from 2007 through 2009. He served for 35 years in some of the US Navy's most high-profile and challenging positions, including: Commander, US Submarine Force; Commander, NATO Submarines; and Program Manager, Navy Marine Corps Intranet. 
