


 <p><b>SC HOPE</b></p>	<h3>Qualifying Criteria</h3> <p>4-Year Institutions Only</p> <ul style="list-style-type: none"> <li>3.0 SC UGP GPA</li> </ul>	<h3>Continued Eligibility Criteria</h3> <ul style="list-style-type: none"> <li>3.0 LIFE GPA, and</li> <li>Earn an average 30 credit hours by end of first academic year (can include hours earned from AP, IB, CLEP, or dual enrollment).</li> </ul> <p><i>If SC HOPE recipients have satisfied these criteria at the end of their first academic year, they can be enrolled in the LIFE Scholarship program.</i></p>

 <p><b>Lottery Tuition Assistance</b></p>	<h3>Qualifying Criteria</h3> <p>2-Year Institutions Only</p> <ul style="list-style-type: none"> <li>Complete FAFSA or FAFSA waiver,</li> <li>Enroll in at least six credit hours</li> </ul>	<h3>Continued Eligibility Criteria</h3> <ul style="list-style-type: none"> <li>Maintain satisfactory academic progress;</li> <li>After attempting 24 hours, earn a minimum 2.0 GPA;</li> <li>and Complete the FAFSA annually</li> </ul> <p><i>Students are not eligible to receive Lottery Tuition Assistance for more than one certificate, diploma, or degree earned within any five-year period unless the additional certificate, diploma, or degree constitutes progress in the same field of study.</i></p>
