## **Consideration of Proposed Changes to Licensing Procedures and Regulations**

#### **Background**

At its September 6, 2001, meeting the Commission on Higher Education requested that a task force be constituted for the purpose of reviewing the criteria and procedures for licensing of nonpublic postsecondary institutions. Commissioners Cathy Harvin and Harry Lightsey co-chaired the task force. Membership on the task force included a business representative, a public institution representative, two private institution representatives, a State Board for Technical and Comprehensive Education representative, and a representative from each of the standing committees of the Commission. The task force met on three occasions and recommended several changes to the regulations. The Committee on Academic Affairs and Licensing met on January 15, 2002, and considered the changes recommended by the Licensing Task Force. Six members of the task force also attended the Committee meeting. Opportunity was provided for input from institutions and staff. The suggestions were strongly considered at the task force meetings and at the Committee on Academic Affairs meeting. Based on additional lengthy discussion at the Committee meeting, revisions were made. Licensing Task Force Co-Chair Cathy Harvin will present the final document at the March 7<sup>th</sup> Commission meeting.

The task force reviewed the current criteria for licensing. It also considered the results of a comparison of the licensing criteria for the states in the SREB region. The task force discussed at length the licensing criteria and the need for additional resources for enforcement of the licensing criteria.

In general terms the proposed changes to the regulations expand the consumer protection focus of the statute and regulations; provide more direction for institutions concerning policies and procedures for record-keeping; establish more rigorous requirements for faculty and administrators; prescribe limitations for transfer credit; mandate review and evaluation; remove the fee schedule from the regulations; and give the Commission the authorization to set fees.

# Recommendations

The Committee recommends that the Commission approve the proposed changes to the regulations summarized below to be forwarded to the general assembly.

In addition to the changes to the regulations, the Committee recommends that the Commission approve a procedure requiring institutions to submit a letter of intent outlining basic information about the institution and the need for the proposed programs. The letter of intent is distributed to the public and private institutions operating in the state at least 60 days prior to the next scheduled meeting of the Committee on Academic Affairs and Licensing.

#### **Attachment 1**

# Guidelines for Fee Structure Considered by the Task Force and Accepted by the Committee on Academic Affairs

Removing a set fee schedule from the regulations will allow the Commission the flexibility to adjust fees as required to offset the costs incurred in supporting the licensing function. Examples of how fees may be adjusted are indicated below:

- Increase the percentage upon which the fees are based (I.E., from one-half of one percent to three-fourths of one percent)
- Increase the maximum fee for initial and renewals (I.E., from \$1,000 to \$5,000)
- Increase the maximum fee for amendments to add programs or sites (I.E., from \$500 to \$2,500)
