ATTRIBUTE LEDGER

TAPE.STUDENTD contains data for all students for a given year and semester at institutions that were awarded LIFE, Palmetto Fellows, Need-based Grants, Hope, and Lottery Tuition Assistance. Consistent with ASCII format, fields and files are delimited by physical position. One record type is contained in this file and three data types are identified as follows: Life Disbursement Data Record (**DATA_TYPE field = "D"**), Palmetto Fellows Disbursement Data Record (**DATA_TYPE field = "P"**), Need-based Disbursement Data Record from Public Institutions (**DATA_TYPE field = "N"**), Need-based Disbursement Data Record from Tuition Grants Commission for Independent Institutions (**DATA_TYPE field = "G"**), Hope Disbursement Data Record (**DATA_TYPE field = "H"**), Lottery Tuition Assistance Disbursement Data Record (**DATA_TYPE field = "T"**), Pell Grant Record (**DATA_TYPE field = "E"**), and Foster Care (**Data_Type field = F**). For all records, **REC_TYPE is specified with the constant "E"** to aid in identifying the record. If "E" is not present, then a discrepancy will be detected during the edit process. Nulls are represented as all nines in both alphanumeric as well as numeric fields. All fields are mandatory.

*EXP_FAM_CONT & EXP_PER -- reported for Need-based, **LTAP, & Pell** Recipients

*GIFT_AID & GIFT_PER -- reported for Palmetto Fellows Recipients only
