

Agenda Item VII. b.

The editing process for enrollment and scholarship data has been updated. From **fall 2007 forward**, scholarship data will be cross-checked with enrollment data. This process will occur in both the enrollment and scholarship load and edit of data. If there are scholarship awards within the data for terms prior to fall 2007, these edits will not occur.

Listed below are the edits and the warning messages:

- 1) All scholarship/grant students are checked for a matching enrollment record.
 - "Student Id Not Found On Enrollment (Warning-Auditable)"
 - "No Enroll Rec-Student Cannot Rec Enhanced Amt-Warning Auditable"
- 2) All scholarship/grant students are checked for degree-seeking status.
 - "Degree Lvl Eq 14, Must Be Deg Seeking"** unless the student is a lottery tuition assistance high school student
- 3) For LIFE, Hope, Palmetto Fellows, Lottery Tuition Assistance, and Need-based students (public only)
 - a. Must be full-time
 - "Hope Awd; Student Enroll Status Not Eq Full Time-Warning Auditable"
 - "Life Awd; Student Enroll Status Not Eq Full Time-Warning Auditable"
 - "Pal Fell; Student Enroll Status Not Eq Full Time-Warning Auditable"
 - b. Cannot have a race code of 1, non-resident alien
 - "Data Type Cannot Have Race = 1"**
- 4) For LIFE and Palmetto Fellows students – Enhanced amounts- 4 year institutions
 - a. If first year student, award amount cannot exceed \$2500 (LIFE) and \$3350 (PF) for the term.
 - "Stu-Level Freshman-Pf-Additional Money-Warning Auditable"
 - b. If not a first year student and award amount for LIFE is > \$2500 and <= \$3750 for the term, then the student must be a major in one of the approved programs.
 - c. If not a first year student and award amount for PF is > \$3750 and <= \$5000 for the term, then the student must be a major in one of the approved programs.
 - d. If not a first year student and award amount for PF is > \$3350 and <= \$3750 for the term, then the amount is a-okay.
 - e. Messages associated with programs for the enhanced amounts
 - "Enhanced Amt Valid For Undergraduates Only"
 - "Enhanced Amt Valid At Masters Level Only"
 - "Enhanced Amount Valid At Bach/Masters Only"
 - "Enhanced Amount Valid For 1st Prof Only"
 - "Inv Life Amt; Program Not Eligible-Enhanced Amt-Warning Auditable"
 - "Inv Pf Amt; Program Not Eligible-Enhanced Amt-Warning Auditable"
- 5) Foster Care
 - a. Student must be a need-based student also (public only).

- 6) National Guard College Assistance Program (CAP)
 - a. Disbursement record cross checked with National Guard CAP file (all soldiers that are eligible)
 - "Student not found in the National Guard College Assistance File"
 - "Student is found in the National Guard College Assistance File but is not eligible for the award."
