

2019-2020 LEGISLATION OF INTEREST FOR HIGHER EDUCATION

The 2019 Session (1st regular session) of the 123rd SC General Assembly convened on January 8, 2019 and is scheduled to end sine die on May 9, 2019. Bills introduced during the 1st session and not passed will be carried over to the 2nd session, which begins on January 14, 2020 and is scheduled to end sine die on May 14, 2020
