

↑ South Carolina National Guard College Assistance Program (SCNG CAP)

The South Carolina National Guard College Assistance Program (SCNG CAP) offers financial assistance to members of the South Carolina Army and Air National Guard by providing incentives for enlisting or remaining for a specified time. SCNG CAP is administered by the Commission on Higher Education along with the South Carolina National Guard.

Army National Guard SCNG CAP recipients may receive up to a maximum of \$5,500 enrolled in a two-year or four-year program at eligible SC Institutions per academic year. Air National Guard SCNG CAP recipients may receive up to a maximum of \$11,000 per academic year if enrolled in a two-year program at two-year or four-year eligible SC Institutions OR a maximum of \$5,500 at eligible SC four-year Institutions per academic year. The cumulative total of all SCNG CAP benefits received for FY-2023 *2024 is in proviso (funds are temporary and awarded for this year only) and may not exceed \$22,000* (Upon approval by General Assembly for FY23-24). These SCNG CAP benefits can be awarded up to the cost of attendance as defined by Title IV regulation. However, the benefit maximum per award year will be reduced if, in combination with other financial aid, the cumulative total of all aid received exceeds the cost of attendance.

▲ South Carolina National Guard College Assistance Program Information

The South Carolina National Guard College Assistance Program (SCNG CAP), established in 2007, offers financial assistance to members of the South Carolina Army and Air National Guard by providing incentives for service in either the South Carolina Army National Guard or South Carolina Air National Guard. SCNG CAP is administered by the Commission on Higher Education, along with the South Carolina National Guard.

South Carolina Army National Guard CAP recipients may receive up to a maximum of \$5,500 per academic year if enrolled in a two-year or four-year program at eligible South Carolina institutions.

South Carolina Air National Guard CAP recipients may receive up to a maximum of \$11,000 per academic year if enrolled in a two-year program at two-year or four-year eligible South Carolina institutions, OR a maximum of \$5,500 at eligible South Carolina four-year institutions per academic year.

Upon approval by the General Assembly for FY23-24 the cumulative total of all SCNG CAP benefits received for FY-2023 - 2024 is in proviso (funds are temporary and awarded for this year only and may not exceed \$22,000*).

These SCNG CAP benefits can be awarded up to the cost of attendance, as defined by Title IV regulation. However, the benefit maximum per award year will be reduced if, in combination with other financial aid, the cumulative total of all aid received exceeds the cost of attendance.

IMPORTANT NOTICE: The SCNG CAP application window for the 2023-2024 academic year runs from 12:01 a.m. June 1 through 11:59 p.m. on August 1. The SCNG will not accept applications outside of this window unless otherwise noted. CAP is awarded on a first-come, first-served basis.

General Definitions

SCNG { Program Definitions.

"Academic year" shall be defined as the beginning twelve-month period as defined by the institution for the awarding of financial aid to a student and which includes regular terms (fall, spring, or trimester) or other terms (summer and other) in any combination.

General Definitions

"Home Institution" shall mean the institution where the student is currently enrolled as a degree-seeking student and may be eligible for financial aid at the same institution.



General Definitions

"Eligible Program of Study" is defined as a program of study leading to:

- (1) a less than one-year certificate or certifications approved by the SC Technical College System;
- (2) courses completed as the education component of a registered apprenticeship;
- (3) an eligible educational program that leads to a certificate or other recognized educational credential (e.g., diploma) as defined by the U.S. Department of Education for participation in federally funded financial aid programs and prepares students for gainful employment in recognized occupations;
- (4) the first associate's degree or a second associate's degree earned at a minimum of five years after receiving the first associate's degree;
- (5) a two-year program that is acceptable for full credit towards the first bachelor's degree; or
- (6) the first bachelor's degree.

- (1) Be in good standing with the active NG at the beginning of each academic year and remain a member in good standing with the active NG throughout the entire academic year for which benefits are payable;
- (2) Have valid tuition and fee expenses from an eligible institution;
- (3) Maintain satisfactory academic progress as defined by the institution;



To qualify, an applicant must:

- (4) Be a U.S. citizen or a legal permanent resident who meets the definition of an eligible non-citizen under State Residency Statutes;
- (5) Be admitted, enrolled, and classified as a degree-seeking full-time or part-time student at an eligible institution in South Carolina; and
- (6) Satisfy additional eligibility requirements as may be promulgated by the Commission.

C. For continued eligibility, students must apply prior to the beginning of the fall term of each academic year by the established deadline as determined by the National Guard, to continue to meet all eligibility requirements.

D. Transfer students who are eligible prior to the beginning of the academic year for the college assistance program and who transfer mid-year to another eligible institution may be eligible to receive the assistance for the spring term if they continue to meet eligibility requirements.

* Students must submit a Change of Request form to the National Guard.

The Chief Executive Officer at each eligible independent and public institution shall identify to the Commission on Higher Education an institutional representative who is responsible for the operation of the Program on the campus and will serve as the contact person for the Program. The institutional representative will act as the student's fiscal agent to receive and deliver funds for use under the Program.

A. The South Carolina Commission on Higher Education in conjunction with the National Guard shall be responsible for the oversight of functions (e.g., guidelines, policies, rules, regulations) relative to this Program with the eligible independent and public institutions. The Commission on Higher Education shall be responsible for the allocation of funds, promulgation of guidelines and regulations governing the CAP, any audits, or other oversight as may be deemed necessary to monitor the expenditure of funds.

The National Guard:

- Responsible for Officers continuing their service with the National Guard for at least four years after completion of the most recent benefit awarded or degree completion.
- Responsible for any and all student appeals.
- Responsible for providing a list of all eligible Guard members to CHE through the SCNG CAP Web Portal.
 Only Guard Members who are on the list shall be awarded the College Assistance Program benefits.

B. According to the Audit Policies and Procedures for Scholarship and Grant Programs Manual, all eligible independent and public institutions must abide by all Program policies, rules and regulations. Institutions also agree to maintain and provide all pertinent information, records, reports, or any information as may be required or requested by the Commission on Higher Education or the General Assembly to ensure proper administration of the Program.

Military Mobilization

Service members who are enrolled in college and are affected by military mobilizations will not be penalized for the term they are required to withdraw after the full refund period based on the institutional policies and procedures. Institutions are strongly encouraged to provide a full refund of required tuition, fees and other institutional charges or to provide a credit in a comparable amount against future charges for students who are forced to withdraw as a result of military mobilization.

Additionally, service members will not be penalized for any credit hours earned while on military mobilization.

Military Mobilization

Service members who are enrolled in college and are mobilized for an entire academic year may renew the scholarship for the next academic year, if they met the eligibility requirements at the end of the prior academic year. Service members who did not use the college assistance program benefits/terms of eligibility during this period due to military mobilization shall be allowed to receive the college assistance benefits during the succeeding term.

The home institution will be responsible for receiving verification of military mobilization status, from the National Guard, attempted semester hours, credit hours earned, and eligibility for benefit renewal for the next academic year in accordance with Section 62-253.

A. Qualified members of the National Guard may receive college assistance program benefits up to an amount equal to one hundred percent of college cost of attendance, provided, however, these college assistance program benefits in combination with all other grants and scholarships shall not exceed the cost of attendance at the particular eligible institution in any given award year.

1) CAP benefits cover the cost of attendance; however, the benefit maximum per award year may be reduced if, in combination with other financial aid, the cumulative total of all aid received would exceed the cost of attendance.

(2) The annual maximum grant will be determined prior to the beginning of each academic year based on the amount of available program funds.

(3) Disbursements of this grant will typically be paid in two (fall semester, spring semester, or its equivalent) equal disbursements. Any remaining funds can be used in any succeeding terms prior to annual expiration date.

Guard members who qualify under ADA and Section 504 of the Rehabilitation Act of 1973 must meet all eligibility requirements as defined in "Program" Benefits and Maximum Assistance" Sections except for the full-time enrollment requirement if approved by the Disability Services Provider at the home institution. Disability Services Provider must provide written documentation to the Office of Financial Aid prior to each academic year verifying that the student is approved to be enrolled in less than full time status. 

Scenario #2

Inquiry from a two-year Institution:

We have a full-time student (12 credit hours) who is eligible for LIFE, CAP, and Pell. After determining that based on the student's Cost of Attendance of \$13,021 and his eligibility for a maximum Pell Grant \$7,395 and a SC Air National Guard College Assistance Program award of \$11,000, we could not award LIFE.

The student is still over-awarded based on his CAP Air National Guard and Pell awards by \$5,626. Do we reduce the CAP Air National Guard by \$5,626 so that his total aid does not exceed his Cost of Attendance or is there some provision to permit him to keep the SC Air National Guard College Assistance Program award of \$11,000 [\$5,500 per semester]?



Answer Scenario #2

CAP Benefits in combination with all other grants and scholarships shall not exceed the cost of attendance. The benefit maximum per award year may be reduced if, in combination with other financial aid, the cumulative total of all aid received would exceed the cost of attendance.

62 252. Program Benefits and Maximum Assistance

A. Qualified members of the National Guard may receive college assistance program benefits up to an amount equal to one hundred percent of college cost of attendance, provided, however, these college assistance program benefits in combination with all other grants and scholarships shall not exceed the cost of attendance at the particular eligible institution in any given award year; and the cumulative total of all college assistance program benefits received may not exceed eighteen thousand dollars.

(1) These college assistance program benefits cover the cost of attendance; however, the benefit maximum per award year may be reduced if, in combination with other financial aid, the cumulative total of all aid received would exceed the cost of attendance.



62-259 Institutional Disbursement of Funds

D. After the last day to register for each term of the academic year, the institution will verify enrollment of each recipient of each recipient and award amount based upon enrollment status (Check eligibility dates before awarding).

E. The institution must submit a request for funds and/or return of funds by the established deadline each term. The Commission will disburse funds to eligible independent and public institutions to be placed in each eligible student's account. In addition, a listing of eligible recipients by identification number with the award amounts must be sent to the Commission on Higher Education by the established deadline each term. At this time, any unused funds must be returned to the Commission immediately.



(3) In the event a student withdraws or drops below eligibility requirements after the institution's refund period and therefore must pay tuition and fees for full-time or less-than-full-time enrollment, the benefits may be retained pursuant to the refund policies of the institution.

- (1) In the event that a student who has received a benefit withdraws, is suspended, ineligible under Section 62-253 C. (1), or otherwise becomes ineligible, the institution must reimburse the college assistance program (CHE) for the amount of the benefit for the applicable term pursuant to the refund policies of the institution.
- (2) The institution is responsible for collecting any amount due to the institution from the student.



DEADLINES TO SUBMIT A REQUEST AND/OR RETURN INVOICES:

Per section 62-259 E. of the SCNG CAP Regulation, the institution must submit a request and/or return of funds by the established deadline each term. A Student Enrollment list <u>must be attached to the invoice</u> (including term, credit hours, and award amount). Please verify your records to ensure that all requests and/or returns of funds are submitted <u>before</u> each term deadline.



A student from XYZ College completely withdrew for the Fall semester and withdrew after the schedule change period (drop/add) and will still be charged for classes.

- Would the student still be eligible to receive CAP benefits?

Section 62-259 (3) allows for the institution to use SCNG CAP funds to pay any balance owed on tuition and fees

In this student's case, the student was enrolled during the Full Fall Semester and withdrew after the 5th calendar

XWY College is allowed to invoice CHE for the tuition and fees (the benefit) charged to the student after drop and

A. The Commission shall disburse benefits awarded pursuant to this chapter to the eligible institutions to be placed in an account established for each eligible student.

(1) In the event that a student who has received a benefit withdraws, is suspended, ineligible under Section 62-253 C. (1), or otherwise becomes ineligible, the institution must reimburse the college assistance program for the amount of the benefit for the applicable term pursuant to the refund policies of the institution.

(2) The institution is responsible for collecting any amount due to the institution from the student.

(3) In the event a student withdraws or drops below eligibility requirements after the institution's refund period and therefore must **pay tuition and fees** for full-time or less-than full-time enrollment, the benefits may be retained pursuant to the refund policies of the institution.



CHE DATA Submission Deadlines to CHEMIS:

When your institution submits scholarship files to the Commission on Higher Education Management Information System (CHEMIS), please include the SCNG CAP awards in this file. To prevent delay in payment the inclusion of the SCNG CAP awards in your institution's scholarship file upload in CHEMIS is required to reconcile invoices (Invoices and CHEMIS files must match). The SCNG CAP web portal must be current and accurate because the web portal is used for eligibility and awarding purposes.

• All CHEMIS Discrepancies will need to be resolved in the next upload to prevent delays in future invoices.

<u>ATTENTION:</u> Data will be transmitted to CHEMIS through the SC Technical College Office EDSS application.
